Re: Demand for Special Meeting of the Members to Vote on Proposed Bylaws Amendment Attached Hereto as Exhibit A and Incorporated by Reference

We, the undersigned Members of Val Vista Lakes Community Association, each eligible to vote and collectively representing at least one-tenth (1/10th) of all votes of the Membership, hereby demand that the Association call, notice, and hold a Special Meeting of the Members for the sole purpose of considering and voting upon the proposed Bylaws Amendment attached hereto as Exhibit A and incorporated by reference into this Demand.

This demand is made pursuant to Article III, Section 2 of the Association's Bylaws and A.R.S. § 33-1804(B).

Purpose of the Special Meeting

The purpose of the Special Meeting is to consider and vote upon adoption of Exhibit A, a proposed amendment to the Bylaws that:

1. establishes felony-based eligibility standards for Directors, committee members, and certain Board-appointed volunteer roles; and
2. requires Board vacancies to be filled by election of the Members within a stated time period rather than by Board appointment, except for limited interim service if necessary to preserve a quorum.

Demand

The undersigned demand that the Secretary cause notice of the Special Meeting to be given to all Members as required by the Bylaws and Arizona law, including notice that states the general nature of the proposed Bylaws Amendment.

Each separately executed signature page, whether signed in ink or electronically, that identifies this Demand and is collected in support of this Demand shall be deemed part of and incorporated into this Demand.

Member Affirmation
